RESOLUTION NO. 527

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PARKER, ARMSTRONG COUNTY, PENNSYLVANIA, AUTHORIZING, EMPOWERING, AND DIRECTING THE PROPER OFFICERS OF THE CITY COUNCIL TO EXECUTE AN AGREEMENT WITH CENTRAL TAX BUREAU OF PENNSYLVANIA, INC. (CENTAX) WHEREUNDER CENTAX IS RETAINED AS THE EXCLUSIVE TAX OFFICER FOR THE COLLECTION, ADMINISTRATION, RECEIPT AND ENFORCEMENT OF THE PROVISIONS OF THE RESPECTIVE ORDINANCES OF THE CITY COUNCIL LEVYING AND ASSESSING THE EARNED INCOME TAX FOR A TERM COMMENCING ON THE 1<sup>ST</sup> DAY OF JUNE, 2001, AND ENDING ON THE 31<sup>ST</sup> DAY OF DECEMBER 2006 TOGETHER WITH SUCH EXTENSIONS AS MAY BE AGREED UPON, SAID ORDINANCES HAVING BEEN ADOPTED UNDER AND PURSUANT TO THE AUTHORITY OF THE LOCAL TAX ENABLING ACT (ACT 511, P.L. 1257); SAID AGREEMENT TO BE SUBSTANTIALLY IN THE FORM ATTACHED HERETO; APPROVING AND ADOPTING THE RULES AND REGULATIONS PREPARED BY CENTAX COVERING THE EARNED INCOME TAX:.

WHEREAS, the City Council of the City of Parker has determined to retain CENTAX in the capacity of exclusive Tax Officer for the collection, administration and enforcement of the Ordinances of the City levying and assessing the Earned Income Tax; and

WHEREAS, CENTAX as submitted a proposed Agreement to the City Council outlining its duties and responsibilities to the City for the collection, administration and enforcement of the aforementioned taxes.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Parker, Pennsylvania and it is hereby resolved by and with the authority of the same:

SECTION I: That the proper Officers of the City Council of the City of Parker be, and they are hereby authorized, empowered and directed to execute an Agreement with CENTAX whereunder the said CENTAX is retained in the capacity of exclusive Tax Officer for the City of Parker for the collection, administration and enforcement of the Earned Income Tax levied and assessed by the City Council of the City of Parker under and pursuant to the respective applicable Ordinances of the City Council, said Agreement to be in substantially the form attached hereto.

SECTION II: The City Council of the City of Parker does hereby adopt the Rules and Regulations as prepared by CENTAX for the Earned Income Tax.

SECTION III: That any resolution or part of resolution conflicting with the provisions of this resolution be and the same are hereby repealed to the extent of such conflict.
